### Royalty free runtimes

## Individual Developer License

This license allows to an **individual person** to develop applications using our component. This license is valid to redistribute the component with **1 (one) Desktop or Console** app and valid to deploy the component with **1 (one) website**. This type of license is **not valid for Cloud** (AWS, Azure, Kubernetes etc).

## Small Company License

This license allows to a **company** (up to 10 developers that are working on any project that uses the SautinSoft component) or a group of **developers (up to 10)** to develop applications using our component. This license is valid to redistribute the component with unlimited number of desktop and Web-applications and deploy the

component with **unlimited number of websites**. This type of license is **valid for Cloud** (AWS, Azure, Kubernetes etc).

### **Large Company License**

This license allows to a large company (**unlimited number of developers** that are working on any project that uses the SautinSoft component) or a group of unlimited developers from to develop applications using our component. This license is valid to redistribute the component with unlimited number of desktop and Web-applications and deploy the component with **unlimited number of websites**. This type of license is **valid for Cloud** (AWS, Azure, Kubernetes etc).
